Agenda: A. Korzun made a motion to accept the agenda with the addition of 13 excess weight permits, addition of annual financial plan for the town highways, certificate of compliance for town road and bridge standards. Seconded by F. Wyatt. Approved.

Lister's Report: The Town was successful in the Henkel lawsuit for the change of the appraisal value to \$1,000,000. Looking into recovering costs. Request for list value adjustment.

Planning Commission – Shade Tree Preservation Study: Received grant for establishing a shade tree preservation plan. Looking for public participation. It's unclear what the state statutes allow for local governance through shade tree plans versus policies versus ordinances.

Conservation Commission Letter to Selectboard: Reviewed the letter and discussed with those present. The Selectboard will continue the process of reclassifying the lower Gaynor Road as petitioned by the townspeople in 2020.

Class 4 highway policy: Read through a proposed policy for Class 4 highways and Town Trails and discussed.

35 mph speed limit: Discussed the process for setting speed limits in town.

Town Administrative Assistant position: The Selectboard decided to hire Erin Lorentz for the Town Administrative Assistant position.

Town Buildings' Maintenance: Discussed lighting changes at the Town garage.

Aaron Korzun made a motion to authorize both the Certification of Compliance for Town Road and Bridge Standards and Network Inventory, and the Annual Financial Plan – Town Highways. F. Wyatt seconded. Approved.

Aaron Korzun made a motion to accept the excess weight permits for: Belden Construction LLC, Phoenix Feeds and Nutrition, Champlain Construction, Connecticut Valley Construction, Parker Excavation, Kilburn Transport, Cardinal Logistics Management Corp., Fabian Earth Moving, J.P.
