Wednesday October 6, 2021**

Meeting called to order by S. Nicholson at 7:00 PM.

Motion made by S. Nicholson to follow the agenda with the addition of Andrew Roy work in ROW, need for Road Commissioner to sign standard grant agreement, and Lister item. F. Wyatt seconded. All in favor, motion approved.

New Business:

Changes in Current Use: Sharon Winnicki provided information on properties with changes in Current Use.

Sharon Winnicki would like for there to be a public meeting with GMP (separate from a Selectboard meeting) regarding the Crown Point Road underground powerline project.

Standard Grant Agreement with state: The Road Commissioner signed a grant agreement with the State of Vermont for \$14,800.

Work in the ROW-Martin, Wells, Roy: S. Nicholson made a motion to approve the following work in right of way permits: Andrew Roy on Shunpike Rd., Bradley Martin on Wilmouth Hill Rd., Geoff Wells on Lincoln Hill Rd. F. Wyatt seconded. Approved.

Planning Commission Report: Laura Black and Melissa Reichert discussed that various revisions need to be made to the zoning and subdivision regulations. Also discussed Class 4 road issues and a draft for the general work in ROW ordinance.

Traffic Ordinance Amendment: Tabled until we have a draft amended ordinance to review.

Catering Permit for Angler Pub LLC: Request for a catering permit for 1204 Bailey Road on 10/16/21. S. Nicholson made a motion to approve a catering permit for Angler Pub LLC at 1204 Bailey Road on 10/16/21. F. Wyatt seconded. All in favor, motion approved.

Review 9/15/21 Minutes: S. Nicholson made a motion to accept the minutes from the 9/15/21 meeting. F. Wyatt seconded. All in favor. Motion approved.

Review Orders: Motion made by S. Nicholson to correct Order #9A from \$2,763.31 to \$2,198.88 and accept Selectboard Order #10 for \$24,174.84 (\$21,786.50 was for town garage bond payment), and Roads Order #10 for \$316,334.39 (\$306,026.10 was for paving with a large portion covered by a state grant). F. Wyatt seconded. All in favor of the amended motion. Motion approved.
