- 3. Discussion on weather data and pollinators

Rita is a Master Garden and gets updates on invasives. She can relay information from The Master Garden's program at UVM Extension. They have information on plants, insects and fungi. There is a monthly disease round-up that she attends. We have uncommon birds in the area and we need the pollinators to support the insects that they eat. Pam knows a lot about the invasive plants in Town. It is possible to replace some of the ornamental invasives such as burning bush with a different plant — a swap to a native. This is a program that could be sponsored by the town. Rita is willing to collect data and feed it to us. Rita and Pam are willing to draft sections on pollinators and invasives for the Town Plan. Suggested length is one page.

Shrewsbury has been reclassified as a Zone 5 in the United States Department of Agriculture plant hardiness map. Carmine has a weather station. He has been collecting data every 5 minutes since April of 2010. Temperature, humidity, dewpoint, rainfall rates, and wind gusts. He reports to the National Weather Service, Weather Underground and other sites. The data has been quality assured. He has also done a pond ice out for their pond. He can compile data on last frost in the spring and first frost in the fall for us. His version of ice out is when there is no ice in the pond. He has his information on www.Hinckleyfarm.com.

What is our objective for having the pollinator and invasive sections. We can promote education on the issues, have policies related to solar installations, provide recommendations and where to get more information. We should report that the SCC has created a pollinator garden and request assistance form them.
