Laura attended the meeting of the Land Use Review Board for Teir 1a status which gives them more development review responsibilities. The Board was impressed with Rutland Regional Planning Commission's presentation on the Tier 1 areas. Laura attended the Tier 3 meeting held by the Land Use Review Board for the Rutland Region. The Regional Plan puts shalls IN **bold**
- 6. Review draft of Forest section

We reviewed the draft of the Forestry section. There was a question about Policy 7 validity. There were questions about the list of techniques to conserve land. We need to search and see if PUDs are in the zoning. Some of these need definitions. Laura wondered if the Forest section was to be in Natural Resources and Working Lands. Melissa plans to do a section in working lands on Forests and this section was for Natural Resources.
