

**Minutes of Selectboard Meeting  
May 20<sup>th</sup>, 2026**

The meeting was convened at 6:30 PM.

**Agenda:** Motion made by A. Korzun to follow the agenda with the following additions: Report from the Town Health Officer and an Excess Weight Permit for Structural Wood Co. Seconded by F. Wyatt. All in favor, motion approved.

**Grand List Extension Request:** Mimi Burstein *Vermont Master Property Assessor* has requested 30 days to complete Shrewsbury's Grand List due to her workload. A. Korzun made a motion to approve the 30-day extension request for M. Burstein. Seconded by F. Wyatt. Approved. **Note:** Assessors will contact homeowners before visits. You can expect letters related to reappraisal in April or June of 2027.

**Easement for Northam Road Culvert:** Jack Facey who is Legal Counsel for Shrewsbury was unable to come.

**New Business/ Open to the Public:** The speed cart is out on Lincon Hill and will be running soon.

**Discussion of Wing for the F-600:** D. Cavoto wants to discuss the new plow for the F-600. He believes it would be helpful for salting the roads in winter, and employees wouldn't need a CDL to use the plow allowing for a more accessible position. D. Cavoto would like to use the Equipment Sinking Fund to buy this attachment. The Selectboard supports the purchase of the Wing using the Equipment Sinking Fund.

**Report from the Town Health Officer:** A dog bite occurred on April 25<sup>th</sup> reported on April 30<sup>th</sup> and the victim believes the dog should be put down. C. Schneider will be contacting the victim to file a report to the Rutland Sheriff's department who is the Animal Control Officer.

**Excess Weight Permit:** A. Korzun made a motion to approve the following Excess Weight Permit for Structural Wood Co. M. Cimonetti seconded. Approved.

M. Cimonetti made a motion to approve the bid for \$24,377.00 from Hawley Electric Inc. to upgrade the electrical service and install two new heat pumps at the Town Office. A. Korzun seconded. Approved.

**Review Minutes:** A. Korzun made a motion to accept the 5/6/2026 Selectboard meeting minutes with the clarification that the sentence "He noted that the classifications could continue to change as the process evolves" is a reference to the discussion referring to Act 181 and not the Rutland Regional Plan. The correction of the names Rich Biziak and Adrienne Raymond and adding the distinction of Planning Commission to Melissa Reichert. Seconded by M. Cimonetti. Approved.

**Review Orders:** M. Cimonetti made a motion to approve the Selectboard Orders #5A for a total of \$4,550.86 and Road Orders #5A for a total of \$16,352.18. Seconded by F. Wyatt. Approved.
