

**Minutes of Selectboard Meeting
July 1st, 2026**

Present at meeting: *Selectboard Members:* Aaron Korzun, Marc Cimonetti, Francis Wyatt. *Town Clerk:* Rebecca Rice. *Admin Assistant:* Alaina Cimonetti.

Active Participants: Dan Cavoto *Road Commissioner.*

The meeting was convened at 6:35 PM.

Agenda: Motion made by A. Korzun to follow the agenda with the following additions: 2027 Grants and Aid and a Class 2 Road Paving Grant for 2027. Seconded by F. Wyatt. All in favor, motion approved.

2027 Grants and Aid: This grant is for stone lining ditches along roads. We got \$24,000 this year (2026) and we got \$17,000 for next year (2027). A. Korzun made a motion to accept this grant. Seconded by M. Cimonetti. Approved.

Class 2 Road Paving Grant: This grant is for paving in 2026-2028 at a value of \$200,000. This will be used this year (2026), and it will be used for Lincoln Hill Rd. This means we will likely not get more grant funding for paving until after 2028. A. Korzun made a motion to approve this grant. Seconded by F. Wyatt. Approved.

Road Commissioner Report: Bids are due for the Lincoln Hill Road paving project on 7/8/26 and will be reviewed at the next scheduled Selectboard meeting which is 7/22/26. D. Cavoto is pursuing contract removal of some dangerous roadside trees. The Selectboard will be getting D. Cavoto a cell phone that will be able to handle all the new apps the state requires him to use.

Forest Fire and Fire Protection Statute Changes: In Act 162 of 2006 that goes into effect of July 1, 2026, the state decided that the fire chiefs are now the new fire wardens, this means the new warden is now Phil Severy. Town residents should continue to contact the current fire warden unless there are any updates from the Fire Department explaining otherwise.

Office Software Discussion - Microsoft 365: The board is looking to move forward with a plan to create one main Microsoft Admin

New Business / Open to the Public: A reminder that the next Selectboard Meeting on July 15th is canceled and has been rescheduled to the 22nd of July.

Review Minutes: A. Korzun made a motion to accept the 6/17/2026 minutes. Seconded by M. Cimonetti. Approved.

Review Orders: M. Cimonetti made a motion to approve the Selectboard Orders #7 for a total of \$2,701.05. Also approving Road Orders #7 for a total of \$6,239.41. Seconded by F. Wyatt. Approved.
